  - b. Supporting documentation related to the request must be provided to the Administrator's office by noon on the Thursday prior to the meeting. The Chairperson may remove requested agenda topics that are made without supporting documentation.
- 2. The Select Board encourages public participation as follows:
  - a. Town residents can bring comments before the Select Board that require discussion and are on the agenda, only after being recognized by the Chair. If your issue is not on the agenda, you may bring it up under "Future agenda items".
  - b. "Topics not anticipated" should be brought to the Chair for possible consideration prior to the meeting.
  - c. Please try to keep your comments short and to the point.
  - d. If it appears that the topic(s) being discussed will consume longer than the time allocated then, at the discretion of the Chair, the matter will be placed on an upcoming Select Board meeting agenda.
  - e. If you believe that your topic will require more time or desire to make a more formal presentation than is allowed under these guidelines, please contact the Town Administrator to ask to be put on a future agenda so that we can properly allocate enough time.
  - f. You are free to ask questions or to make your point for all to consider. However, engaging in active debate with Select Board or audience members will not be allowed.
  - g. All comments and questions must be directed to the Chair of the Select Board per MGL Chapter 30A, Section 20(g).
  - h. Participants are expected to speak from the presenter/guest table.
- 3. Employees and Board members who have business with the Select Board should be placed on the agenda beforehand (see Item # 1.).

## From Massachusetts Attorney General Official Website

## What public participation in meetings must be allowed?

Under the Open Meeting Law, the public is permitted to attend meetings of public bodies but is excluded from an executive session that is called for a valid purpose listed in the law. Any member of the public also has a right to make an audio or video recording of an open session of a public meeting. A member of the public who wishes to record a meeting must first notify the Chair and must comply with reasonable requirements regarding audio or video equipment established by the chair so as not to interfere with the meeting. The Chair is required to inform other attendees of such recording at the beginning of the meeting.

While the public is permitted to attend an open meeting, an individual may not address the public body without permission of the Chair. An individual is not permitted to disrupt a meeting of a public body, and at the request of the Chair, all members of the public shall be silent. If after clear warning, a person continues to be disruptive, the Chair may order the person to leave the meeting, and if the person does not leave, the Chair may authorize a constable or other officer to remove the person.

## Rules & Regulations

## Town of Erving, Massachusetts Solicitation By-Law

- 1. Every person desiring to engage in soliciting within this Town must fill out an application.
- 2. The application must be made seven (7) days prior to desired solicitation date.
- 3. Applicant must truly state all information on application.
- 4. Fee for soliciting is \$25.00 per solicitor.
- 5. Solicitor shall keep on his or her person the Certificate of Registration to Solicit in the Town of Erving.
- 6. <u>Time limit for soliciting</u>: prior to 9:00 a.m. or after 9:00 p.m. of any weekday, or at any time on a Sunday, or on a State or National Holiday.
- 7. If a resident has a card or sign exhibited up or near the main entrance door to the residence reading "*NO SOLICITORS INVITED*", the solicitor will immediately and peacefully depart without disturbing the occupant.
- 8. If requested by a resident to depart, the solicitor will do so immediately.
- 9. Any person who violates this By-Law may be arrested without a warrant in the place where the offense is committed.

RE: Plow Truck Loss & Procurement

On April 4, 2024, the Town's Highway Department experienced a loss of the new 2023 plow truck due to a fire. The truck experienced an issue while being used for plowing. Luckily the operator observed the smell of smoke and was able to safely stop and exit the vehicle before the fire was visible and eventually consumed the cab. First and foremost, the operator is safe, for which we are extremely grateful. The cause of the fire is assumed to be electrical in nature, but an official determination by the investigator has not been completed. The appraiser for the Town's insurance company has deemed the vehicle to be a complete loss.

Concerned with the availability of inventory, I have proactively issued a request for quotes using the State contract VEH110. The State Contract currently has three (3) vendors listed that can provide the F550 plow truck and necessary upfit. The request for quotes has been sent to all three vendors with a requested response date of April 22, 2024.

I have reviewed the situation with the Town Accountant. The Division of Local Services has issued a recent Local Finance Opinion on how to handle proceeds from an insurance claim and for procurements, under MGL c. 44 § 53. The Town can proceed with the replacement of the plow truck, using the proceeds from an insurance claim, as long as the amount is less than \$150,000, without further appropriation. The purchase price of the truck was approximately \$120,000 so I anticipate these allowances to be sufficient. I have attached the Local Finance Opinion of the Division for your review.

Once the quotes are received, I will prepare them for your review.

# **Local Finance Opinion**

LFO 2024-1 February 2024

**TOPIC:** Insurance and Restitution Proceeds

**ISSUE:** Accounting treatment of fire or physical damage insurance policy proceeds or restitution received for damage to city, town or district property

This Local Finance Opinion (LFO) addresses questions relating to (1) the accounting treatment of money received by a city, town or district under an insurance policy or as restitution for damage to its property and (2) the availability of the money for expenditure. This LFO supersedes LFO 2018-2 and any prior inconsistent statements.

# 1. What is the general rule related to the receipt of money by a city, town or district officer or department?

All money received or collected from any source by a city, town or district belongs to its general fund and can only be spent after appropriation unless a general or special law provides an exception, *i.e.*, expressly restricts use for a particular purpose or allows expenditure without appropriation. <u>G.L. c. 44 § 53</u>. Additionally, under ordinary municipal finance laws and accounting standards established by the Director of Accounts, the availability of any receipts or collections for appropriation depends in large measure on when they are received. <u>G.L. c. 59 § 23</u>. If received between July 1 and the setting of the tax rate, they can be treated as estimated receipts to support an appropriation from the levy before the rate is set for the proposed purpose. If received later or not budgeted as part of the tax rate, they are not available for appropriation until after the close of the fiscal year and certification by the Director as free cash.

## 2. Is there an exception to the general rule for insurance or restitution proceeds?

Yes. Pursuant to <u>G.L. c. 44, § 53</u>, money received under the terms of a fire or physical damage insurance policy or received in restitution for damage done to city, town or district property may be spent by the department or officer having control of the property for its restoration or replacement with the approval of the chief executive officer of the municipality or district. No appropriation is required to spend the proceeds for that purpose. Restitution proceeds include, but are not limited to, court-ordered money or money received under relevant agreements or settlements. Additionally, municipalities may spend for this purpose in advance of monies being received. However, whether municipalities spend the money when received or in advance of receipt, this exception <u>only</u> applies where the total amount for the insurance claim or restitution is \$150,000 or less. In the case of spending in advance of receipt, if the monies are not received by the close of the fiscal year after the fiscal year in which the damage occurred, the municipality must report the same in the determination of the applicable annual tax rate or otherwise make provision therefor.

Additionally, the department or officer must spend the proceeds to restore or replace the damaged property on or before June 30 of the fiscal year in which the proceeds are received, or 120 days after receipt, whichever is later. <u>G.L. c. 44 § 53</u>. Upon receipt, the accounting officer must establish an account for the proceeds. If the department or officer does not spend the proceeds, *i.e.*, incur a contractual liability, for the restoration or replacement of the property within that time frame, the accounting officer must close any unspent or unencumbered balance to the general fund.

For example, a fire damages the town's Department of Public Works (DPW) storage shed on February 1 and the insurance company is set to pay the town \$25,000 on its claim for the damage on May 1. Because the amount of the fire insurance proceeds is \$150,000 or less, the DPW can spend the \$25,000, with the approval of the chief executive officer, to repair or replace the shed either immediately, in advance of the monies being received, or once the monies are received on May 1. No appropriation is needed, but the DPW can only spend the proceeds for this specific purpose and must do so on or before June 30 of the fiscal year the town received payment on its claim, or 120 days after receipt, whichever is later. Any unspent or unencumbered money at the end of that time period will close to the general fund. If monies were spent in advance of receipt and monies were not received by the close of the fiscal year after the fiscal year in which the damage occurred, the municipality must report the same in the determination of the applicable annual tax rate or otherwise make provision therefor.

Moneys received as reimbursement for economic loss do not receive similar preferential treatment under <u>G.L. c. 44 § 53</u>. In addition, revenue cannot be credited to an appropriation. Therefore, if an existing appropriation was used to finance the repair or replacement of the property, the insurance or restitution proceeds are credited to the general fund.

# **3.** How should accounting officers treat the receipt of insurance or restitution proceeds in excess of \$150,000?

The Director of Accounts establishes accounting standards for municipalities and districts and determines available funds in accordance with those accounting standards. <u>G.L. c. 44, § 38; G.L. c. 59, § 23</u>. The Director has determined that where the total amount received for the insurance claim or restitution is more than \$150,000, the proceeds may be reserved for appropriation during the fiscal year received for the purpose of restoring or replacing the damaged property. These proceeds may be the only or a significant financing source for the repair or replacement of the damaged property. Depending on when received, however, the municipality or district might have to wait for a considerable period of time before it could repair or replace the damaged property.

Because <u>G.L. c. 44, § 53</u> establishes insurance and restitution proceeds as a class of receipts that may be spent for a particular purpose without first being certified as free cash, the Director has determined that money received for an insurance claim or restitution in an amount greater than \$150,000 is available for appropriation for that restricted purpose until June 30. The accounting officer should establish a receipt reserved for appropriation account and credit the proceeds to that account. Any proceeds not appropriated by the legislative body by June 30 to repair or replace the damaged property close to the general fund. In the ordinary course, the proceeds would then become part of the free cash certified by the Director as of the following July 1 and once certified, may be appropriated for any lawful purpose.

Note, however, that if the proceeds are received on or before March 31, and the municipality or district wants to appropriate them for a purpose other than to repair or replace the damaged property, it may request that the Director update its free cash certified as of the previous July 1 to include the unappropriated proceeds and make them available for appropriation for the other purpose on or before June 30.

RE: Maple Avenue PFAS

The Town is working with Tighe & Bond on the annual post-closure monitoring of the Maple Avenue Landfill. As part of this process, the Town, through its vendors, conducts water sampling with three (3) adjacent properties. In this most current round of testing requirements, you will remember that the Massachusetts Department of Environmental Protection (MassDEP) required testing and reporting for PFAS which expanded the anticipated scope of services that Tighe & Bond provides for this work.

Test results from the samples were recently received and one (1) of the three (3) sample sites identified trace levels of PFAS that required reporting to the property owner and MassDEP. The other test results were to acceptable limits and the results have been shared with property owners. To better understand the PFAS result, MassDEP has required the Town to conduct a second round of sampling and lab test of the site. I have authorized Tighe & Bond to proceed with that work. Once the test results are received, we will convey them to MassDEP and the property owner. In the meantime, the Town has provided the property owner with potable water.

Until the results of the second round of testing are received, currently, there are no further actions for the Town to take. Once the results are received and understood and we have the opportunity to meet with MassDEP, we can advise what, if any, next steps the Town should take.

Re: FRCOG's Application for a 604B Water Quality Management Planning Grant for Keyup Brook

As we have previously discussed, the Planning Department at the Franklin Regional Council of Governments has agreed to work with the Town to continue to study the Keyup Brook, and to work with community members and regulatory agencies to identify best management practices (BMP) and strategies that the Town could explore with property owners to improve the health of Keyup Brook and to protect properties from the erosion that has been experienced in recent years. FRCOG has offered to apply to the Massachusetts Department of Environmental Protection's Nonpoint Source ("NPS") Management Section in the Watershed Planning Program ("WPP"), Bureau of Water Resources ("BWR") for a planning grant that would build on the previous study and prepare an action plan with BMP's that the Town can pursue.

The application period for the Water Quality Management Planning Grant program closes on Wednesday, May 8, 2024. If we would like FRCOG to proceed, the Town should provide letters of support for the project stating our need and willingness to support the project. A draft support letter is included for your consideration and review. We can make any changes that you see fit.

The Town of Erving enthusiastically supports the application by the Franklin Regional Council of Governments (FRCOG) for a 604(b) Water Quality Management Planning Grant to fund a project for the Keyup Brook Watershed combining elements of Water Quality Assessment, Climate Resiliency Water Quality Planning, and Development of Implementation Plans.

The Keyup Brook is a defining feature of Erving Center, our Town's civic center and second largest village. The brook flows directly through the village on its way to the Millers River, passing close to roads, homes, commercial and historic buildings, and through Riverfront Park. It is used by the community for recreation and fishing. The brook is listed for E. coli and is experiencing significant fluvial erosion during heavy storms, which adds large amounts of sediment to the brook. In July 2021, during a significant storm, the Town lost a bridge over the brook and homeowners in the lower watershed experienced flooding of their properties with damage to retaining walls. The 4,545–acre watershed is predominantly undeveloped, making it possible to restore water quality and keep it that way. Stormwater management strategies in the lower watershed are needed to control pollutant loading to the brook, and stream restoration to reduce erosion in the middle and upper watershed is needed for both water quality restoration and climate resilience in our community.

Given these two major pollutant concerns, the Town of Erving is fully committed to investigating the causes of the erosion and identifying both upland and urban best management practices (BMPs) for managing stormwater. FRCOG's proposed project will provide the analysis needed to understand erosion occurring in the brook and identify upland restoration opportunities. It is also needed to further develop concepts for urban stormwater BMPs identified in the Keyup Brook Watershed-Based Plan. This project should key up a number of potential projects for s.319 Implementation funds and Municipal Vulnerability Preparedness (MVP) program action grants.

Thank you for your consideration of FRCOG's proposal. We look forward to your support of this

project.

RE: Former IP Mill Site Redevelopment RFP Procurement & Potential Next Steps

On February 07, 2024, the Select Board released a request for proposals (RFP) for the redevelopment of the former International Papermill site, with an original submission deadline of March 21, 2024. Throughout the process, the Town issued six (6) addenda, conducted three (3) optional site visits, and amended the submission deadline to April 8, 2024.

As of the submission deadline, the Town only received one response. The response is from the Hancock Academy, which is attached for your review. While the submission was received by the deadline, the submission does not include the statutorily required forms and attestations, as well as the requested project development explanation that is outlined in the RFP document. I have spoken with a representative of the Hancock Academy, and they acknowledge this. I have informed the representative that my recommendation to the Select Board will have to be to formally reject the proposal as non-responsive and to fail the procurement process.

With that said, this is another potential partner that is interested in operating in Erving at the site. The Select Board is limited, statutorily, as to how we can make real property available, unlike an Economic Development Industrial Corporation (EDIC). We have had several small businesses express interest in locating in Erving and at this site, but the scale of this project is beyond what they can do alone. Pursuing an EDIC through special legislation may be prudent.

I have provided MassDevelopment with an update on the status of the procurement as well as the request for demolition funding on the Annual Town Meeting warrant. MassDevelopment is encouraging the pursuit of demolition funding and, if appropriated, suggests reissuing the RFP with the availability of funding to support the site demolition. I have included MassDevelopment's communication for your review.


## **Our Mission**

# **Benefiting the Community**

We believe that small businesses and tradespeople are the lifeline of our communities, so we wanted to do something about it. We recognized small businesses have been severally impacted over the years because of the Pandemic, online shopping, etc.

We also recognize that we are facing the greatest shortage of qualified tradespeople that the industry has ever seen. With the average age of a tradesman being 54 years old, we are quickly approaching a crippling loss. In addition, we want to empower the next generation of people by introducing and mentoring them in the trades.

Equality in the construction industry is also one of our top priorities. Our hope it to develop strong relationships based on being inclusive and to partner with certified disadvantaged businesses (minority, women, and Disabled American Veterans) within your community.

In 2022 we started Hancock Academy to help qualified small local businesses remodel existing or new brick and mortar shops in our communities using local aspiring tradespeople.







# **Benefiting the Community Cont.**

#### Funding:

We fund Hancock Academy through the sales of salvaged and overstock materials. In addition, as a registered 501c3, we receive grants and donations.

#### Hancock Academy Grant Recipients:

Local representatives and the community will nominate a potential grant recipient. Our board will review all nominees and select a grant recipient based on the following criteria: impact on the community, number of jobs created, cost of the project, etc.

#### **Project Execution:**

Once a project has been identified, and budget is established, our architects and designers work with the business owner to design the space. Although we understand that some materials will need to be purchased new, our goal is to utilize as much of the Hancock Academy inventory as possible.

Our construction team is comprised of local general contractors, subcontractors, and local apprentices. General contractors support the project with project managers and superintendents. Our subcontractors are required to employ 1 local person for every 2 experienced tradespeople.

#### **Project Completion and Continued Support:**

We partnered with SBA to provide a business mentor to all Hancock Academy recipients for 2 years.

Optional: Hancock Academy grant recipients are enrolled in our "pay it forward" program. This program requires the business to reinvest a small portion of their profits back into the Hancock Academy program to help fund the next project.








## **Repurposing-**

The Department of Environmental Protection has invited us to participate in a research and development grant opportunity through Re-X. The challenge set by Re-X is to identify materials that can be reintegrated into the circular economy. We have teamed up with **Lina Gonzalez**, founder of **SpadXTech**, and together, we will work towards identifying two source materials that can be upcycled. Our first proposal is to take salvaged acoustic ceiling tiles and convert them into soundproof insulation for commercial and residential use. Hi Bryan,

I was nice to catch up with you regarding the IP Mill project.

Amanda and I had a chance to talk with our team about the project. While we didn't come up with a solid solution we thought of an approach to take that may be able to help with a future RFP. The idea is that the town approves the additional funds to clear the entire site then goes out to RFP with the goal of attracting a developer by offering to utilize those funds to demolish as much or as little of the site for the most advantageous development. The City of Worcester took a similar approach with a former courthouse building. The RFI that the city put out is attached for your reference. As part of the RFI, they offered to demolish a part of the building, based on the preferred developer's plans, before handing over the property to a developer. In the case of Erving, by offering to work with a developer to demolish what they need demolished for their plans to work, it may attract developers who were not previously interested because of the costs associated with demolition.

Let us know if you have any questions. Amanda was involved with the Worcester project and may be able to fill you in on some more details.

RE: Traffic Control Devices on North Street & Church Street

In response to concerns about speeding on Church Street and the lower section of North Street, the Select Board authorized the Highway Department to purchase four (4) sets of temporary rubber speed cushions. The purpose of the equipment was not only to slow traffic with the goal of improving safety but was also to assess placement and to determine if residents and the Town wanted to consider permanently altering the road surface to incorporated speed humps. The equipment arrived during the summer of 2023 and was installed by late summer. Site walks were held with neighborhood residents to identify preferred locations for placement. Site conditions, location of utilities, and other factors informed final placement of the cushions for the pilot.

This was the first time the Town had purchased and installed this type of equipment and there was certainly a learning curve. To securely fasten each speed cushion across the travel lanes, hundreds of 7" anchors had to be drilled into the pavement. This in addition to some extremely hot days, resulted in several days of installation. While receipt of the equipment and installation took longer than originally hoped, that equipment remained in place until the last week of October to prepare for the winter weather and plowing season. In November 2023, the Town's Office of Community Planning sent residents in the neighborhood some survey questions and invited residents to share their thoughts on the pilot effort and whether the speed humps should be considered for a permanent installation. Responses to that survey invitation have been included for your review.

As the Select Board and the residents work to determine the desired layout and improvements for the neighborhoods of North Street and Church Street, I want to remind the Select Board that the Town is likely eligible to apply for a second implementation round of funding for Complete Streets. The Town's Complete Streets Prioritization Plan calls for safety improvements and pedestrian accommodations on both streets. As a long-term strategy, the Town could work to secure engineering services for a complete streets project and apply to the Massachusetts Department of Transportation (MassDOT) for implementation funding that could address the deficient sidewalks, the possibility of the speed humps, and/or explore other traffic calming measures. This could likely dovetail with the Church Street Bridge replacement in 2025.

Residents of Church Street, North Street, Highland Avenue:

As of October 25, 2023 the Highway Department has removed the speed humps in Erving Center. These speed humps were installed late summer 2023 at the request of neighborhood residents as a pilot project to see how they affected traffic and the residents on Church Street and North Street. They have been removed so the roads can be effectively and safely plowed when snow arrives.
